Second Posting of Proposed Amendment to Bylaws:

Executive Board Members

Amend Article VIII, Executive Board, Section A, # 1.

- 1. The members of the Executive Board shall be the elected officers, past state presidents, the chapter presidents and State Committee Chairs. The treasurer shall be a voting member except when she receives remuneration for her services.**

This amendment will be voted on at the 2025 State Convention.
