TECH CORNER: WEBSITE COMPLIANCE

ebsite compliance forms (Form 72) are due at Society International Headquarters (HQ) on October 31! This form ensures that chapter or state organization websites meet the appropriate standards to be linked to the Society International website, <u>dkg.org</u>. This form must be filled out at the beginning of each biennium, so even if a chapter or state organization's webmaster submitted one in the last few years, it must be submitted again.

Chapters or state organizations can get their websites linked to the Society International website by following these steps:

- 1. Create a website. There are plenty of free, user-friendly website builders that can help make this step easy. The HQ webmaster recommends sites like Google Sites or Weebly, which guide users through the website creation process.
- 2. Review the website. Webmasters should double-check to make sure their website meets all of International's website standards. Standards include things such as...
 - using black or gray font for body text, and a pale or white background for each page;
 - clearly labeling links for easy navigation;
 - · only publishing finished pages; and
 - including the proper legal requirements (see full checklist for details).
- 3. Fill out Form 72 Society Website Compliance Assurance Form. Once a webmaster has double-checked that their chapter or state organization's website meets Society International standards, they must fill out Form 72 and click "Submit."
- **4. Receive a Seal of Linkage.** After the Society HQ webmaster receives a submitted Form 72, she will review the website and ensure it meets all International Society standards. If no changes are required, the state or chapter webmaster who submitted the form will receive a seal of linkage.
- **5. Post the seal.** Once a webmaster receives the seal of linkage, she must be sure to post it at the bottom of her chapter or state organization's website homepage. After the seal is posted, the website will be linked to dkg.org!

Webmasters can scan the QR code above, <u>click this link</u>, or head to **www.dkg.org > Resources > Webmaster** to submit an updated compliance form, learn more about International's website standards, and get in-depth tips about how to build a website. ACTIONS OF THE 2024 INTERNATIONAL CONVENTION IN NATIONAL HARBOR, MARYLAND

2022-2024 Administrative Board Actions

The following are the major actions taken by the 2022-2024 DKG Society International Administrative Board during its meeting on July 8, 2024, at the Gaylord National Resort & Convention Center in National Harbor, Maryland, USA.

- 1. The approval of an additional vendor was approved as a Consent Agenda item.

 Context of the Action: The use of a Consent Agenda provides for a more efficient use of meeting time while maintaining appropriate oversight. Consent Agenda items are available for review prior to the meeting and often include the ratification of actions approved via email or other electronic means. Consent Agenda Items may be pulled for discussion by request of any board member.
- 2. The Board Policy Manual was accepted and approved as presented in its final draft. Context of the Action: Because there have been many changes in operations due to the sale of the building and the transition to a stronger use of GAPP (guidelines, policies, and procedures), the board policy manual and the former handbook required some review, revision, updating, and consolidation. After work by an appointed team of board members and evaluation and editing by the board, the new Board Policy Manual was presented for formal approval. The manual will be reviewed and revised as appropriate by future boards each biennium.
- 3. The Administrative Board approved (by consensus) the following resolution to be presented by a board member at the 2024 International Convention:

Resolution: that the International President appoint a committee to work in consultation with the association's attorney to prepare a revision to the DKG Constitution and International Standing Rules for consideration and voting by the 2026 International Convention.

Context of the Action: With the increasing number of proposed amendments to the governing documents each biennium and the feedback from members regarding the time spent at convention focusing solely on the amendments, the Administrative Board feels it is time to consider a revision of the governing documents. This revision would involve a committee of members and legal counsel to develop bylaws based on best association practices and the needs of DKG in the future. With appropriate governing documents that do not need constant amendment, convention activities can focus on business of a different nature. The revised document would be presented to the 2026 International Convention for approval.

- 4. Recommendations for the next 2024-2026 Administrative Board were approved by consensus:
 - At the request of the International Issues Task Force, the Board recommends the 2024-2026
 Administrative Board review the strategic plan and, to embrace and safeguard the international nature of DKG, weave it's recommended strategies throughout the DKG Strategic Plan.

- Appoint a Visionary Network Ad Hoc committee to develop the logistical support needed and provide oversight for the Visionary Networks.
 - o Implement 10 to 12 Visionary Network groups by early September to capitalize on the enthusiasm of the pilot groups and planning team, as well as the interest of other members.
 - o Include at least one person from the Educational Excellence committee on the Visionary Networks Ad Hoc Committee with the intention of transitioning oversight to that committee the following biennium.
 - o The DKG Executive Director serves as the committee liaison.

Context of the Action: It is customary for a Board to make recommendations to the Incoming Board. After discussion, the 2022-2024 Administrative Board determined the following recommendations to the 2024-2026 Administrative Board would promote a continuance of initiatives begun within the context of the Avenue M project.

2024-2026 Administrative Board Actions

The following are the major actions taken by the 2024-2026 DKG Society International Administrative Board during its meeting on July 14, 2024, at the Gaylord National Resort & Convention Center in National Harbor, Maryland, USA.

- 1. The appointment of Dr. Helen Popovich as 2024-2026 International Parliamentarian was announced. Context of the Action: The international president appoints a parliamentarian to serve as international parliamentarian at the beginning of her biennium. (Article VI Section C.1.a.(3) of the Constitution)
- 2. A motion to invite the Headquarters professional staff to attend regular meetings of the Administrative Board was approved by consensus.
 - Context of the Action: The Society Headquarters professional staff (Finance Director, Membership Director, Technology Director) are not members of the Administrative Board but provide information, resources, and insight that are valuable to board members during decision making and strategic planning. The invitation to attend meetings supports this role as well as their work as liaisons to international committees. The Executive Director serves as an ex-officio member of the Administrative Board and attends all meetings in her capacity as corporate secretary.
- 3. A motion to approve the corporate resolutions for signatory authorization for the accounts at Chase Bank was approved.
 - Context of the Action: Because two authorized signatures are required for approval on Society checks/ payments, it is the practice of the Society to appoint the current International President, Executive Director, and Finance Director as signers. Specific resolutions (per U.S. banking regulations and individual bank requirements) are required, in conjunction with documentation of board approval, in order to remove the outgoing international president from the accounts and add the incoming international president to the accounts.

4. A motion to approve the corporate resolutions for signatory authorization for the accounts at Wells Fargo Bank was approved.

Context of the Action: Because two authorized signatures are required for approval on Society checks/payments, it is the practice of the Society to appoint the current International President, Executive Director, and Finance Director as signers. Specific resolutions (per U.S. banking regulations and individual bank requirements) are required, in conjunction with documentation of board approval, in order to remove the outgoing international president from the accounts and add the incoming international president to the accounts.



- 5. Without objection, a recommendation was forwarded to the Executive Board to approve the following Ad Hoc Committee and Task Force groups:
 - a. The Diversity, Equity, Inclusion, and Accessibility (DEIA) ad hoc committee
 - b. The Visionary Network ad hoc committee
 - c. The Revision Task Force
 - d. The Avenue M Task Force

Context of the Action: In order to accomplish the work of the Society and the vision of the Board, the International President can appoint appropriate task force and ad hoc committees with approval of the Executive Board, per Article VIII Section A.1.c.(2). The DEIA ad hoc committee will continue the work it began in 2022-2024, the Revision Task Force will address the resolution approved by the 2024 International Convention to revise the governing documents, and both the Visionary Network ad hoc committee and the Avenue M Task Force will address the continued implementation of the recommendations presented in the Avenue M Report.

- 6. Without objection, a team consisting of the International Parliamentarian, 2022-2024 Constitution Committee Chair, and 2024-2026 Constitution Committee Chair was appointed to update the governing documents with the changes made during the 2024 International Convention.
 - Context of the Action: Following the approval of amendments to the Constitution during the 2024 International Convention, updates must be made to the governing documents and state organizations/ chapters should be notified of the potential need for revision in practices and/or documents at their respective levels of the organization. The ad hoc committee will facilitate the development of documents informing state organizations and chapters of these updates.
- 7. A motion to authorize the executive director to determine committee liaison assignments (electronic ballot will be distributed within the next weeks) was approved by consensus.

Context of the Action: Although the Executive Director works in collaboration with the incoming president to recommend liaison assignments, the Administrative Board approves the assignment of staff to serve as members ex officio without vote [Article VIII Section A.1.e.(9)] in a liaison role to international committees. Due to the timing of transitions for both the incoming executive director and the 2024-2026 International President, further deliberations were needed prior to the presentation of a formal recommendation for the approval of the Administrative Board.

8. By consensus, the Administrative Board approved to provide one day during the International Leaders Orientation Meeting (ILOM) in August 2024 for strategic planning by the 2024-2026 Regional Directors in preparation for their work with state organization presidents, in collaboration with the International President and Headquarters staff.

Context of the Action: As a result of action taken by the 2024 International Convention, Regional Directors will no longer be responsible for the planning and facilitation of international conferences. With a focus on their primary responsibilities to serve as a liaison and resource to state organizations (Article VI, Section C.3), they will use time during ILOM to create common and consistent strategies to support the growth of state organizations in their respective regions.

Action on Proposed Amendments

The 2024 convention disposed of 94 proposed amendments (PAs) to DKG's *Constitution* and *International Standing Rules*. The numbers and wording of the PAs are available in the 2024 March/April edition of the *DKG NEWS*. State organizations and chapters can view their relevant changes on <u>dkg.org > Publications/</u> <u>Documents > Constitution & ISR</u>. Changes to International documents will also be posted there when available.

PAs 1–15—the Category I consent agenda—were adopted. Note: PA 7 was pulled for discussion and adopted. These amendments moved procedural rules and guidelines from the *Constitution* and *International Standing Rules* to Guidelines and Policies/Procedures (GAPP). These guidelines, policies, and procedures remain in force unless amended by the Executive Board.

PAs 16–61—the Category II consent agenda—were all adopted, except for PA 17, which was withdrawn. Most of these PAs made minor changes in capitalization of titles, arrangement of existing wording, or modifying duties of boards and committees. PAs making more substantive changes, were:

- PA 16 enables a collegiate member's years of membership to count toward eligibility for state organization and international scholarships;
- PAs 29, 30, and 31 authorize co-presidents at the chapter and state organization levels;
- PA 43 authorizes all meetings at every level of the Society to be held in person, electronically, or both ways;
- PA 45 authorizes collegiate members to be counted in determining a state organization's voting power in a roll call vote; and
- PA 55 makes the Editorial Board an international standing committee.

PAs 62-94—the Category III floor agenda—were each debated and then voted on by the convention, except for PA 87, which was withdrawn. PAs 64, 65, 69, 72, 73, 77, 78, 80, 82, 86, 88, 91, and 92

were lost. The others were adopted or adopted as amended.

- PAs 62 and 63 make minor changes in the wording of the Society's name;
- PAs 66-68 make minor changes in the wording of the Society's purposes;
- PAs 70 and 71 give state organizations and chapters full authority for determining any scholarship fees;
- PA 74 authorizes reimbursements for the European Forum chair to attend the international convention;
- PAs 75 and 76 were amended to assign the immediate past president certain responsibilities, but not to make her a member of the International Nominating Committee;
- PA 79 makes the Leadership Discovery Centre an international standing committee;
- PA 81 modifies eligibility requirements for international elected positions and PA 7 moves the requirements to GAPP;
- PAs 83-85 authorizes and provides funding for Canadian, European, Latin American, and U.S. forum-sponsored conferences;
- PA 89 authorizes the Administrative Board to recommend whether to adopt or not to adopt proposed amendments to the *Constitution*;
- PA 90 authorizes the convention to adopt by a 90% vote proposed constitutional amendments that have not received four months' notice;
- PA 93 enables members to propose amendments to GAPP; and
- PA 94 amends the Society Ethics Policy to incorporate a procedure for addressing ethical violations.

UPDATE: JAPAN

apan State started 2024 by participating in a local non-profit bazaar at the women's center "SORE" ("so-ray") in Kochi City. Our Alpha Chapter, led by Atsuko Oka, donated the proceeds to the Red Cross for disaster relief in Ishikawa prefecture. "Reach out, stay flexible, and have fun" is our motto for action.

In June, we held our Japan State Convention, where we promoted our ongoing theme of *Diversity*, *Equity*, *and Inclusivity* (DEI). We kicked it off with the 9-day Rikiya Asai Kochi Exhibition 2024 "*Ikiru*" (Living) at the Kochi Liberty and Civil Rights Museum. Kochi City mayor, Ryugo Kuwana, participated in the ribbon cutting ceremony for the exhibit, which was open to the public, and *Rainbow Connection* high school exchange students from Hawai'i welcomed visitors with a hula dance. Yasuko Kita, our Beta Chapter president, and Rikiya's mother, Miwako Asai, completed the day with a gallery talk explaining Rikiya's paintings.

The following day, Miwako Asai spoke about the pleasures and challenges of being a mother to a child with cerebral palsy. Rikiya was born in Tokyo but has been raised in Hawai'i, enjoying nature and painting. With movement and independence severely limited, Rikiya now requires 24-hour nursing care. Miwako reminded us to enjoy nature and our freedom and to live life to the fullest every day.

With about 700 visitors from the community,

we deemed the Rikiya Asai Kochi Exhibition 2024 "Ikiru" a success for DKG Japan State. Visitors happily received postcards of Rikiya's paintings, pineapple gummies, and chocolates.

Our Japan State *Peace Education* project kept us busy promoting international peace in July. DKG members visited elementary schools presenting "<u>The Blue-eyed Doll</u>" picture-story show (*kamishibai*), in remembrance of the firebombing of Kochi City that took place on July 4, 1945.

Also in July, DKG members once again taught flower arrangement (*ikebana*) to international Kochi University students in both Japanese and English. I am still working with the International High School and Kochi University students to promote the importance of volunteerism.

Yasuko Kita has been working with Kochi University to promote Project Based Learning (PBL) events. DKG sponsored the July event, "A Missionary of Japanese Culture in a Digital Society" at the Kochi Otepia Library. Riko Takemoto from the Fukuda Art Museum talked about the importance of teaching and learning with the use of artificial intelligence (AI). Ms. Takemoto gave examples of how ChatGPT, Claude, and Gemini would describe famous works of Japanese art in words. We learned that DKG members need to stay creative and flexible as future educators.
